Subject: Grants under Proviso to Article 275(1) of Constitution during 2019-20 to the States under Grants-in-aid-General (Recurring) for running of Eklavya Model Residential Schools (EMRSs) – as 3rd installment.

Sir,

In continuation of this Ministry's letter dated 30.05.2019 and 14.08.2019, I am directed to convey the sanction of the President of India for release of an amount of **Rs. 349,63,15,000/- (Rupees Three Hundred Fourty Nine Crore Sixty Three Lakh and Fifteen Thousand only)** as 3rd installment to the State Governments (As given below) towards Grant-in-aid-General (Recurring) under Grants under Article 275(1) of the Constitution during the year 2019-20 for the purpose of EMRSs recurring cost, as approved by PAC in its meeting dated 11.02.2019, 12.02.2019 and 13.02.2019.

You may please transfer the amount immediately to the State Governments and advise RBI, CAS, Nagpur for crediting the above mentioned amount to the accounts of the State Governments in accordance with the procedure laid down in the Ministry of Finance's OM No. 2(45)/ 76-Spl. dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to Programme Division of the Ministry.

3. The expenditure to the tune of **Rs. 349,63,15,000/- (Rupees Three Hundred Forty Nine Crore Sixty Three Lakh and Fifteen Thousand only)** is debitible to the:

Major Head '3601' - Grants-in-aid to State Governments
Sub-major Head 08 - Other Transfer/Grants to States
Minor Head 796 - Tribal Area Sub-Plan
05 - Welfare of Scheduled Tribes – Grants under Proviso to Article 275 (1) of the Constitution.

Demand No. - 98 for 2019-20 of the Ministry of Tribal Affairs

4. The State Government will implement the projects within the amount released by the Ministry and keeping in view the spirit of the provisions contained under Operational Guidelines for Inter-State allocation of funds and implementation of Programmes / Activities under Proviso to Article 275(1) of Constitution of India, issued by Ministry of Tribal Affairs vide this Ministry's letter NO. 11015/01/2016-SG-I dated 20.6.2016 and other relevant instructions issued from time to time.

5. The State Government shall release the funds to concerned EMRS immediately. Further, the State Government shall ensure that funds are utilized for imparting quality education to the tribal students in EMRSs as stipulated in the EMRS Guidelines, 2010 after following due procedure in a transparent manner.

6. Periodic progress reports should be furnished indicating the physical and financial progress as per prescribed format already circulated and revised from time to time. A Certificate of actual utilization of the grants received for the purpose for which it was received, may be


furnished to the Ministry immediately after closure of current financial year by the State Government.
